Vendor Space

Vendor spaces are determined as 10 x 10 foot spaces under 20 x 40 tents at the event. All Vendor spaces are final.

Vendors are to supply their own chairs and have one table will be provided

Vendors may enter the grounds at the main gate at 8:30am for set up, you will be allowed to come in to drop off your goods to set up and park your vehicle in nearby parking asap . Gates open to the public at 11am so please keep this in mind that to be completely set up and ready. Artisan tents will close at 9pm friday and saturday with final close at 4pm sunday, please do not start packing up displays any earlier than 9pm, you are encouraged to stay open til end of each nite. You may leave your set up on site all weekend with security being on site the entire event. No vechicles will be allowed on the grounds until after close on sunday at 4pm . Please do not leave any garbage behind (garbage/recycling will be available). Vendors must not place any display items/merchandise in pathways which will endanger public safety or cause inconvenience to other Vendors.

The assigned space is to be used solely for the display of the Vendor products and services as approved by Sarnia Kinsmen and listed in the contract and agreed upon.

Vendors are liable for any and all damages which they cause to Sarnia Kinsmen, City of Sarnia , Centennial Park and its property in connection with their display/merchandise, etc. Vendors are not permitted to alter or change, including attaching signage to tents or grounds without pre-approval from organizer.

Assignment of Vendor Space

Vendor space will be assigned by the organizer, in which Sarnia Kinsmen reserves the right to alter any location changes, as deemed in the best interest of the vendor and event. Vendors are placed with consideration to a merchandise being offered, displays, etc.

Vendors are not permitted to re-assign or sublet their space, or display any other products or businesses than which agreed upon in this contract.

Payment Policy

Full payment must be received, with this signed contract to be a vendor no later than May 15th 2020 to secure your spot. The contract MUST be returned, payment is non-refundable, even in the event of cancelation by the Vendor.

In the event that the Sarnia Kinsmen Ribfest Event is cancelled, for any reason, by the organizer, the full payment will be refunded.

Advertising and Promotion

Advertising for the 20th Sarnia Kinsmen Ribfest Event will take place through a variety of different sources including radio, newspaper, social media and of course word of mouth!

All Vendors are encouraged to promote their attendance by all means possible including Facebook pages, business website, etc... this ensure's the success for both themselves and the Sarnia Kinsmen Ribfest event.

Insurance and Liability

Vendors must have a representative in attendance, at the assigned space at all times during the Event including setting up and dismantling to protect them against loss or damage.

Sarnia Kinsmen is not responsible for, shall be indemnified and held harmless by the Vendor in this contract from and against any and all claims and damages of every kind, for injury to or death of any person or persons and for damage to or loss of property, arising out of or attributed, directly or indirectly, to the operations or performance of the Vendor and the Vendors agents and employees under this agreement.

The Vendor acknowledges that insurance covering the Vendors property against damage and business interruption losses are the sole responsibility of the Vendor. Vendors may insure their property, at their own expense.

The Vendor agrees and understands that by accepting these rules, that he/she will make no claim of any kind against Sarnia Kinsmen for damage to or destruction of goods, or for any injury that may occur to himself/herself or his/her employees while participating in the Sarnia Kinsmen Ribfest Event for any damage of any nature or character whatsoever.

Sarnia Kinsmen are not liable to the Vendor for any damage to or for the loss or destruction of any Vendor property or merchandise, whether caused by negligence of Sarnia Kinsmen , its officers, agents, servants, employees or otherwise, all claims for any such loss or damage being expressly waived by Vendor who agrees to indemnify and hold Sarnia Kinsmen harmless from such claims.
